

2008 Pinal County Fair Community Stage Entertainer

Thank you for your interest in performing at the 2008 Pinal County Fair on the community stage. In an effort to facilitate all the acts wishing to perform at the fair we ask that you complete the attached application, read and understand the rules of performance, arrive at appropriate time and stick to the schedule set for your performance. We look forward to working with you and your group.

RULES

This application must be completed by each group or solo performer wishing to perform at the Pinal County Fair. Applications must be returned or faxed to the fair office no later than March 24, 2008. Acts presenting a musical presentation should provide a tape or cd of the performance if possible (need not be professional) The person completing this for is responsible for classifying the act, please check the appropriate category for your performance. Each performance will be given a set time to perform. Performances must be completed within that time frame. Setup and tear down of any equipment necessary must be completed within the time allotted.

Acceptable material: Musical acts, theatrical, dance and other performing arts. **No lewd gestures or offensive material will be tolerated**

The stage manager will have complete authority over start and end times of performance. At the discretion of the stage manager performers presenting material other than approved or offensive in nature will be asked to leave the stage and may be removed from the fair. All decisions made by the Fair manager, stage manager or fair employee as appointed by the fair manager will be final.

The fair will provide a PA system for use by groups. Those bands requiring a monitor system will be expected to provide their own equipment and technical support. You will be contacted by a representative of the fair to discuss your needs if you or your act is accepted.

Tickets: Each person performing in the accepted group will be admitted to the fair at no cost. One adult will be admitted to the fair at no cost for each performer under the age of 18. Unless prior arrangements have been agreed upon in writing the fair will allow free admission for up to two support people.

Parking: Vehicles must be parked in the free general parking lot. Groups with equipment will be allowed to park in the loading area while loading and unloading. Arrangements may be made in advance if assistance is needed to move equipment.
